Please be advised that we are solicitors for TVI Pacific Inc. ("TVI") in connection with various publications undertaken by Mining Watch Canada ("Mining Watch") in connection with TVI's Canatuan Mine.

TVI has carefully reviewed various publications contained on the Mining Watch website and has determined that the information stipulated on that website is inaccurate and highly defamatory.

We also understand that representatives of Mining Watch are slated to appear next week before the sub committee on Human Rights and International Development to provide further comment, if any, on the mine.

TVI is concerned that Mining Watch has levelled serious and unwarranted accusations about TVI's activities. TVI hereby provides formal notice that if the Mining Watch website is not properly corrected and/or if any Mining Watch representative gives inaccurate and defamatory information at the forthcoming hearing, that TVI will commence action in the Court of Queen's Bench of Alberta seeking damages for defamation. The purpose of this notice is to put all Directors on notice of that fact to ensure that proper steps are taken by Mining Watch.

TVI demands that all publications in connection with the Canatuan Mine be immediately removed and suspended pending a formal visit to the Philippines mine site. In that regard, if Mining Watch is prepared to immediately remove all publications in connection with the Canatuan mine from its website, TVI will sponsor one member of the Board of Directors of Mining Watch to attend for a nocost review of its operations in the Philippines. TVI is prepared to provide a detailed agenda and to respond to any specific written inquiries arising from that tour so as to insure the dissemination of accurate information.

TVI is prepared to arrange for that tour immediately because it believes it can clearly demonstrate that it carries on its operations in a lawful, socially responsible and environmentally responsible manner. TVI believes that the material in the attachments to this letter is the true story that deserves to be told.

In the meantime, however, TVI does expect that your website information will be taken down and that any information provided in the forthcoming panel hearing be entirely accurate. If it is not, TVI will have no choice but to consider litigation not only as against Mining Watch Canada, but also its Board of Directors and Ms. Coumans.

Kindly govern yourself accordingly.
