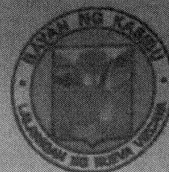



WHEREAS, as of this moment we didn't receive any order from the office of the President, Central or regional office to continue your operation upon the termination of the FTAA; and


WHEREAS, the Barangay council unanimously agreed to pass a resolution for the stoppage of the operation.




